Requesting a Try-on: You may request up to three dresses at a time to be shipped to you to try-on. This is your opportunity to see which dress fits you best. Make sure you can move comfortably, that the dress is the appropriate length, and that it does not distract you from dancing. You are not permitted to wear any of these dresses to any competition, showcase, or event of any kind prior to renting it. To proceed with renting or purchasing one of these dresses, please submit a **RENTAL AGREEMENT** or **PURCHASE AGREEMENT**.

Conditions for trying on dresses: (Please initial next to each line to confirm you understand your responsibilities)

<input type="checkbox"/>	Make sure your hands and body are free from products such as makeup, gels, hairspray, glitter, deodorant, tanner, bronzer, food, lotions, and other oils that can stain the fabric of the dress(es).
<input type="checkbox"/>	Be cautious with your jewelry, heels, and long fingernails, which could damage the dress(es).
<input type="checkbox"/>	Maintain good hygiene standards and wear underwear while trying on the dress(es).
<input type="checkbox"/>	Be delicate with the dress(es) to keep it/them in the best condition possible. If the dress(es) has/have noticeable damage, staining, and/or a large amount of stones missing after your try-on, you will be notified and held financially responsible for up to the full purchase price of the dress(es) for the cost of the repairs. Assessment of the damage will be at the discretion of Next Level Dancing, LLC. If you alter a dress in any way, it will be treated as a purchase. If the dress is lost or stolen while in your possession, it will be treated as a purchase.

Try-on Timeframe: You may try-on dress(es) for a 48-hour period (two days), beginning when the box with your dress(es) is delivered to you. After that it/they must be immediately shipped back to Next Level Dancing, LLC. To return your dress(es), repack them in the same manner they were sent to you and in the same box. You will be provided with a return label. You will be charged \$50 per day for each dress not returned within two days. These charges will continue to incur until the dresses(es) is/are shipped. If the dress(es) is/are not returned within two weeks, it will be treated as a purchase and you will be charged the full purchase price of the dress(es).

Fees: There is a \$10 try-on fee per dress. You are also responsible for the shipping fee both ways. Please submit a **SHIPPING AND DELIVERY AGREEMENT**. Shipping fees will be prorated via a trackable service such as FedEx or UPS, and are based on your location in the U.S. Therefore, your total for shipping both ways could be as low as \$40 or as much \$150, based on how close you are to Columbus, OH and how fast you want them to be shipped. Once we calculate your shipping fee, you will be notified via email of your Total Fee.

Payment: You are also required to submit a **CREDIT CARD AUTHORIZATION FORM** to authorize the shipping fee and to be kept on file for incidentals. No dress will be released until payment in full is received.
