Submitting your Dress: All submitted dresses and their accessories must be received in a clean condition with no holes, odors, stains, or large amounts of stones missing, in which case, registration is free. If dresses are not clean at the time of submission, there will be a \$50 initial cleaning fee for each item. If you agree to rent your dress, Next Level Dancing, LLC will provide dress cleaning between every rental period at no cost to you. Next Level Dancing, LLC has the right to return or refuse dresses that are in poor condition, not geared toward our target market or not likely to be rented or sold.

Dress Returns: This agreement will remain in effect and we will continue to advertise your dress for rental or sale until you request that it be returned. However, we reserve the right to reassess our inventory at any time. To cancel your registration with Next Level Dancing, LLC, please notify us via email and include your dress name and the date by which you would like it returned. If your dress is under contract for rental within the next 30 days, that contract must be honored and the dress will be returned to you after it has been cleaned.

Shipping: If you are unable to personally deliver or pick up your dress from the Next Level Dancing office, you will be responsible for the shipping fees. We recommend packing dresses in a plastic zip bag, placing it in a cardboard box, and shipping by a trackable service, such as FedEx or UPS. In this case, please submit a **SHIPPING AND DELIVERY AGREEMENT** and a **CREDIT CARD AUTHORIZATION FORM**.

If you approve your dress to be rented: Individuals renting dresses from Next Level Dancing, LLC fill out a **RENTAL AGREEMENT** and pay a rental fee of \$200, \$250 and \$275, not including tax and/or shipping. We will establish the rental fee for your dress based on the quality, amount of stoning, and style. When your dress rents for \$200, you receive a \$100 commission, \$250 rental is a \$125 commission, and \$275 rentals are a \$135 commission. Your commission will be mailed to you after the dress has been safely returned at the conclusion of its rental period. If the renter is out of state, your dress will be mailed for try-ons and the rental event via a trackable carrier such as FedEx or UPS.

Priorities: Your dress cannot be rented by two different people for the same event. If your dress is scheduled to be rented for an event and paid for, it may not be taken away from the renter for any reason within 30 days prior to her event, including sale or return to the owner. Other parties will be asked to wait to take possession of the dress until after the event has occurred and the dress has been cleaned. If the event is more than 30 days in the future, and another party is interested in purchasing your dress or you wish for it to be returned, the renter will be asked to consider other dresses in our inventory.
